

2018 SUMMIT RACING EQUIPMENT U.S. MAJORS TOUR CONTINGENCY PROGRAM

CLAIM FORM

REGISTRATION: Competitors must be officially registered each year to participate in the program prior to competing. No awards will be paid if you are not enrolled prior to competing. Additionally, competitors must complete and submit this Claim Form no later than 30 days after each eligible event.

DECALS: All competitors must display two Summit Racing Equipment decals – one on each front fender. **Summit contingency decals** are **NOT** the same as the required **Summit Road Racing decals**, competitors must have both to qualify. Decals are distributed by SCCA and should be requested by contacting SCCA at contingency@scca.com.

VERIFICATION and AWARD PAYMENT: Decal placements must be verified on-site by a tech official - who must sign this claim form (except for 10th place – 10th place does not require a signature, but you still must submit a claim form). Claim forms may be signed to verify decals placements prior to the posting of Official Results. Completed claim forms for each race day must be submitted with a copy of the Official Race Results and will be verified upon receipt. Finishing positions will be verified by the SCCA National Staff; awards will be made to legal finishers only. Awards will be issued by SCCA via email within 30 days of claim receipt.
